

Outline of the AgriBusiness Forum 2015

The AgriBusiness Forum is a business event, aimed at strengthening the Agri-Food sector in Africa, by encouraging partnerships, exchanging of best practices and attracting investments. We believe that the success of Africa depends on the development and growth of its private sector and that the agribusiness sector has an enormous potential for growth.

The Forum, the largest pan-African Agribusiness Forum held on the African continent annually,

attracts a few hundred agribusiness leaders and decision makers: entrepreneurs, financiers, donors,

industrialists, researchers, Government officials, international organisations, NGOs and others from North and South. It is a key meeting point for those who wish to take part in Africa's agro-food sector growth and for those who wish to invest in the sector. The event is a unique combination of **Plenary Sessions, Technical Workshops, Pre-organized Business Meetings** and a **Market Place.** The **EMRC-Rabobank Project Incubator Award of US\$15.000** is also part of the forum, aimed to encourage the African SME agro-initiatives for the benefit of local communities.

Since 2009 the Forum has taken place in Africa: in 2009 in Cape Town, South Africa, in 2010 in Kampala, Uganda, in 2011 in Johannesburg, South Africa, in 2012 in Dakar, Senegal and in 2013 in Kigali, Rwanda. Prior to that, the Forum was hosted in Europe and took place in 2007 and 2008 at the FAO headquarters in Rome, Italy.

Why hold the AgriBusiness Forum in DR Congo



Economy in the Democratic Republic of Congo remained strong in 2013, with a GDP increasing by 8.1% (versus 7.2% in 2012) thanks to extractive industry, trade, construction and agriculture. Growth is expected to remain at 8.5% in 2014 and 8.6% in 2015, driven by mining, reconstruction of roads and energy infrastructure as well as the impact of the agricultural campaign launched in 2012. In line with the vision of the Head of State, Joseph Kabila Kabange, the Prime Minister, Augustin Matata Ponyo, launched several initiatives aimed to transform DRC into an emerging economy by 2030, pledging to relentlessly strengthen the transparency and accountability of public sector spending. Recently, peace

was restored in the Democratic Republic of Congo, paving the way for economic growth and social improvement in the long term.

The AgriBusiness Forum 2015 will bring together over 400 decision makers and professionals from around the world and will be the ideal venue to highlight the business and investment opportunities in DR Congo's agricultural and agro-industrial sector as well as to provide a platform for the promotion of South–South and North–South trade cooperation and investment for the benefit of the entire African agro -food sector.

DRC's Prime Minister and his Government have adopted an ambitious strategy to boost national agroindustrial production: the agro-parks. These are large-scale private-public projects aimed at modernizing the agriculture through mechanization, irrigation and usage of improved seeds, among others, following a demand-driven approach. They are designed to create employment in rural areas, as well as to structure integrated agricultural value chains on a long-term basis.

Facts about agriculture in DR Congo:

- ✓ 80 million hectares of arable land;
- ✓ Abundant water resources;
- Modernisation of abandoned farms and plantations;
- ✓ 73 million people in the country and 250 million in the region to feed;
- Recent improvement in the business climate;
- Existence of the Fund for the Promotion of Industry (FPI) and the National Fund for Agricultural Development (FNDA), providing financial support for agricultural projects


